# <u>Committee Chairman's Report – Gen Grosse</u>:

Since there was not a quorum, the November and January meeting minutes could not be approved. Mrs. Grosse asked the committee for input as to a gift for Mrs. Hanson, it was agreed to present a group Troop photo, gift card and plant.

### MATO Fundraising Report – Gen Grosse:

Mrs. Grosse shared all materials have been purchased, cobbler ingredient prep and trailer load will be Saturday, February 26<sup>th</sup> from 9:00 am to 11:00. The booth needs to be set up by 6:00 on March 3<sup>rd</sup>. Mrs. Anderson shared there are a few slots left for Scouts/families to sign up. Mrs. Grosse will share with the Crew families. Mr. Priest and Mr. Padilla shared the Scouts had a great time camping last weekend even though the fish weren't biting. Mr. Priest mentioned a Crew member had a significant wound and while there was ample first aid materials, he suggests and cautions letting Scouts with wounds attend campouts.
